- "Exploring the relationship of metacognition and mindset in graduate CSD students" (Writing Results).
 - The purpose of this study is to investigate the changes in metacognitive awareness of speech-language pathology graduate students during a first-semester, first-year neurology course.
- "Leadership Training in Communication Sciences and Disorders" (On-Going).

 We seek to identify current leadership training practices that are used in graduate-level CSD training. Plans are to complete a survey with CSD faculty in two phases: 1) a pilot phase where faculty at our home institutions are surveyed and 2) a nationwide survey engaging faculty participants from across the nation.

In an effort to meet the needs of the speech-language pathologist working in the schools and ensure success for children on their caseload, it is essential to understand the day-to day challenges faced when working with children who have been exposed to opioids and have a

history of neonatal abstinence syndrome. Characteristics, traits, and clinical profiles of this population have yet to be clearly defined outside of the neonatal transition units immediately following birth. With that in mind, this research project will define communication traits that children exposed to opioids are likely to exhibit and will provide speech-language pathologists support in the assessment, differential diagnoses, and innovative intervention in the elementary school age years. Findings from this project will be disseminated to local and national audiences of SLPs and other educational professionals, which may include presentation at regional, state and national conferences as well as publications of at least 2 articles in peer-reviewed journals serving this population and/or offering regional one-day workshops around the state.
